
MTSS Professional Learning Catalog

Key terminology, fidelity dimensions, and its role in problem-solving and data-based decision-making are explored. The course also examines the legal foundations for fidelity in education and emphasizes the importance of consistent, high-quality implementation of evidence-based practices for improving student outcomes. The course highlights strategies for building capacity and infrastructure to support fidelity efforts, and the critical role of leadership in promoting a culture of continuous improvement and data-driven decision-making. Setting the Context	1 hour	This course provides participants the rationale behind the structure of the RtI-E Professional Learning Series, a clear definition of a specific learning disability (SLD) according to Florida state regulations and the eligibility criteria for SLD within a Multi-Tiered System of Supports (MTSS). Types of Discrepancies	1 hour	This course provides participants with an understanding of significant discrepancies and their relationship to Florida's Specific Learning Disability (SLD) eligibility criteria. Participants will continue to develop their knowledge and skills related to the Big 5 Ideas, explore the role of Tier 1 in eligibility decisions, and examine how significant discrepancies inform determinations using the 4-prong eligibility criteria. The Rule Outs	1 hour	This course provides participants with the knowledge and skills to apply the Big 5 Ideas and Florida's Specific Learning Disability (SLD) eligibility criteria. It focuses on understanding rule out factors—familial background, environmental or economic, limited English proficiency, and attendance—and their connection to Tier 1 instruction. Dual Discrepancy & Decision Rules	1 hour	This course provides participants with knowledge of the role of Response to Intervention (RtI) in SLD eligibility determination, focusing on the dual-discrepancy model in which students demonstrate both low academic performance and insufficient response to intensive instruction/intervention. Participants will learn about assessing student progress, applying decision rules, and using data-based problem solving to make informed eligibility decisions. Introduction to Tier 3 Problem Solving and Relationship to Eligibility	2 hours	This course provides participants with an understanding of the key characteristics of Tier 3 problem-solving, assessment, and intervention. It introduces Exceptional Student Education (ESE) eligibility criteria within the context of Tier 3 problem-solving and highlights what makes special education unique. As a result of completing this course, participants will be better equipped to support students through effective problem-solving and intervention strategies.
